In shameful vote against the Women's Health Protection Act, Young Kim backs bounty hunters over bodily autonomy

Vulnerable Rep. Young Kim sent a clear message to Californians today: with reproductive freedom and the constitutional right to an abortion under attack, **she sided with bounty hunters over bodily autonomy.**

Young Kim's vote against codifying the critical protections of Roe v. Wade and affirming nearly 50 years of Supreme Court precedent is just the latest evidence that she is grossly out of touch with the people of CA-39. The [majority of Americans](#) support the passage of a national law that would protect the constitutional right to safe, legal abortion and stop radical abortion bans, including the one passed this month in Texas. Yet when it came time to stand up for the people of CA-39, **Young Kim once again voted to control women's bodies and lives over protecting their freedom to make their own decisions free from political interference and vigilante bounty hunters.**

Holds "A" Rating with SBA Pro-Life. Kim holds an "A" rating with the Susan B. Anthony Pro-Life America Group.

Kim has voted consistently to defend the lives of the unborn and infants. Susan B. Anthony’s President Said Exceptions for Rape Were “Abominable.” “Susan B. Anthony List president Marjorie Dannenfelser, who moderated the press conference and whose organization has been a prominent backer of the 20-week ban in its current form, said that she believes that rape exceptions are ‘abominable.’ ‘I agree. I agree that the rape exception is abominable,’ she told LifeSiteNews. ‘I also know that with it, we were able to move forward, and we have the potential of saving 15,000 to 18,000 children a year.
